ROCHDALE MP, Mr Cyril Smith, got himself booked for "ungentlemanly con-duct" on Monday night— by the secretary of Rochdale Soccer Referees Association.

Cyril was due to "play" to a crowd of 130 at the referees' £6.50-a-head annual men's dinner tomorrow.

But he declared himself unavailable 72 hours before the "kick-off"-and left the referees without a substitute.'

declared: "I am disgusted. "I have been on the telephone since 7 pm trying to get a substitute speaker and I haven't got one yet."

Mr Smith, a vice-president of the Referees Association, was a great success as a speaker at last year's dinner.

Mr Harrison of Higher Lomax Lane, Heywood, said he got the first intimation of the let-down when he telephoned

home on Monday night to confirm the arrangements for tomorow night's "do" at the Spinning Wheel Restaurant, Dearnley. He was told by Cyril's mum, Mrs Eva Smith, that the MP would not be attending.

Then he rang Liberal headquarters Drake Street, Rochdale, and spoke to the MP.

Mr Harrison said: "Mr Smith said he was sorry, he would not be coming and anyway I had not confirmed

it in writing.
"He said the Abortion Bill was due on Friday and the rest of the week would be taken up with education. He was going to London, on Tuesday morning and would not be back until Friday night.

"But I HAD confirmed the arrangement—on 11 October last year. And his of on House Commons notepaper, was dated 17 October. I read it

"To be fair to him, his letter did mention the possibility that Parliamentary business might interfere, but I feel he used that as an excuse for not having got in touch with me earlier.

"And anyway, I understand that he spoke to our chairman, Mr Joe Wildman, while attending a function only a fortnight ago and said then that he would be coming.'

Mr Smith was incensed. He said: "They are cheeky sods. I am under no obligation to them. I will not be pushed around by the Referees Association or any other groups to attend silly dinners."

He stressed that his acceptance had been subject to his being free from commitments in the House of Commons.

"I don't know what will be the business of the House more than a week in advance," he said. "This week there are two days on education and the Abortion Bill is scheduled for Friday

He added that he had a brief discussion with member of the association engagement at at an Hill Community School last week, when he said he would attend the dinner if he was in Roch-

## ANGRY SHOUTS AT DITTA PROTEST-MARCH REFUSAL

MR SMITH also turned down an invitation on Monday to join a protest march in support of Mrs Anwar Ditta.

She and members of the Anwar Ditta Defence Committee went to the public meeting of Rochdale Liberal Party which followed the private annual meeting.

Towards the end, members of the Defence Committee accused the Liberals of being racist and arguments broke out. Mrs Ditta and her supporters started to leave, but shouting continued for some minutes.

Earlier, Mrs Ditta asked Mr Smith to join a demonstration on 1 March in support of the campaign to reunite her, in this country, with the three children she claims are hers.

Mr Smith said he would not attend the demonstration. Mrs Ditta's claim had already been given appeal priority and "there is no way you can influence the appeal by protesting. This is the same as a court of

Mr Smith said he dealt with two or three cases a day, which put him in touch with immigration authorities. He would deal with them in his own wav because he did not want to prejudice future cases, and he had been reasonably effective so far.

One of Mrs Ditta's sup-porters shouted: "I know if Cyril Smith wanted to, he could have those children here in five minutes."

Mr Smith said: "I have respect for this system." If MPs could influence the decisions of courts or inquiries, the law would be controlled by Parliament, not by the judicial system.
