FREE THE BRADFORD 12

Dear Friend,

You may know of the arrest in Bradford last July of 12 young Asians who now face trial at Leeds Crown Court on 26th April on charges of conspiracy and offences under the 1883 Explosives Act. All 12 will plead not guilty to the charges, but if convicted could be sentenced to life imprisonment.

Many of the Bradford 12, as they have now come to be known, are members of the United Black Youth League, an independent radical organisation committed to fight against the racism of British society. It has been well known to the police for its successful record in defending black people against the racist immigration laws and against police and fascist harassment. Its members have been active in anti-deportation campaigns and in securing Anwar Ditta's right to bring her children from Pakistan to Britain. They campaigned to secure the acquittal of Gary Pemberton, a black worker who faced charges trumped up by the W. Yorkshire Police. Beneath the fantasy of the charges levelled against the Bradford 12, this is their real crime in the eyes of the State: they are on trial for their previous lawful activity in fighting racism.

The arrest and the trial of the Bradford 12 is a blatant attempt to suppress the legitimate political activity of a black organisation and therefore an attack on the right of black people to organise politically. This amounts to a major political attack on the black community, the working class as a whole and democratic rights in general. There can be no doubt that it will be the political views of the defendants that are on trial when they come to court, for the conspiracy charges relate in effect more to their political activity than to anything else.

Against all principles of justice, they spent 3 months behind bars without trial; they are now subjected to bail restrictions which deny their right to partake in any public meeting that concerns their defence. In all aspects of this case, the conduct of the police and judicial authorities has highlighted a disturbing abuse of their powers. The entire prosecuting and judicial process would appear to be indicted of a conspiracy to subvert the course of justice in relation to the black community – a community which has already expressed its utter lack of belief in the even-handedness of the forces of 'law and order', and which will be alienated even further as a result of this trial.

A national Campaign has been launched to free the Bradford 12, and support groups have sprung up in many towns and cities. The Campaign has already received support from:
