WE note with satisfaction that the Caribbean Times (5 March) has at last allowed the Bradford 12 Defence Campaign an opportunity to reply to the inaccurate and highly misleading "Scales of Justice' article of 29 January.

However. we were horrified and enraged to find in your issue of 26 February a further attempt to undermine and tarnish the Campaign by linking it with the 'Racism in the Bar' article. This act on your part, as you must well know, was unjustified, criminally irresponsible and totally unforgivable.

We were also dismayed by the further misleading comments contained in the Editor's Note attached to our reply. Four points remain to be made:

- We reaffirm unreservd support for the struggle of black lawyers fighting racism in the Bar; moreover, the black lawyers who will appear for our defence will be held committed and accountable to our community.
