The Immigration and Nationality Laws of this country are bringing misery to the lives of countless black people. Over a thousand deportations are carried out every year without any campaign or public outery. Many women and children have been waiting for periods of 10 years and more to join their husbands here. And those who are lucky enough not to have been affected yet live in fear that they'll be the next in line.

JUST LOOK AT SOME EXAMPLES OF RECENT CAMPAIGNS THAT HAVE BEEN LAUNCHED ABOUT PARTICULAR INDIVIDUALS AND THEN MULTIPLY THAT BY 1000'S AND YOU'LL GET SOME IDEA OF WHAT'S HAPPENING.

HALIMAT BABAMBA - Nigerian She left her violent husband and then had to fight against being deported with her two children. She won her campaign.

MALIKA BENKHELEFA - Moroccan Home Office want to deport her and her 8 yr old daughter. They claim this is in the public interest. Like Halimat, she left her husband because of his violence and was then told she must be deported. She is still campaigning. JOSEPHINE THOMAS- Grenadan
She came here in 1962 to
work and has paid insurance
and tax over 15 yrs of full
employment. She has 4 British born children. She
stayed out of Britain for
just 5 months over the per
mitted two years* and for
that she is being told to
leave the country she has
made her home.



* JOSEPHINE IS ONE OF THE MANY UNSUSPECTING VICTIMS OF THE RETURNING RESIDENTS RULE. This rule says that people who are settled in this country must not stay out of the country for periods of more than two years. If they do so they will lose their right to settle here regardless of how long they have been living here.

THERE ARE MANY WOMEN LIKE
THESE WHO JOIN THEIR

HAVE NO INDEPENDENT RIGHTS.
If her husband leaves or is
deported then a woman must
go too. If she leaves her
husband she will not be
allowed to remain. Many
women are afraid to leave
violent or unhappy marriages
for fear of being deported.
