JUSTICE FOR STEVEN SHAW AND VICTIMS OF POLICE HARRASSMENT

WE DEMAND JUSTICE

Steven Shaw was part of a demonstration against the visit of Leon Brittan to Manchester University on 1 March 1985, which was attacked and broken up by Manchester police. Following his involvement in the Defence Campaign and the Independent Inquiry into the events of that night, he was: mysteriously burgled, pulled-up for alleged speeding four times though never charged, and then held in Bootle Street police station for five hours of questioning during which he was stripsearched and assaulted, resulting in internal injury.

Complaints about police violence and harrassment were investigated by Avon and Somerset police, but few students had any confidence in them, especially after their inquiry team handed over supposedly confidential statements, to Manchester police prosecution solicitors.

A Manchester City Council-sponsored Independent Inquiry concluded in November 1985 that there was "unacceptable use of force and abusive language by police officers ... against innocent civilians participating in a peaceful demonstration". In reference to complaints of police harrassment made by Steven Shaw and others they believed that there was "a deliberate attempt by unknown police officers to frighten and harrass key witnesses to the Inquiry ... in the course of this criminal offences have been committed by police officers."

This harrassment is still going on. On 2nd February, Steve was attacked in a Manchester street by the same two men who had interrogated and assaulted him at Bootle Street last year. This time they broke his nose, stamped on his hands, hit him with a bottle and stubbed out cigarettes in his face. He has also received death threats

Despite accurate descriptions and long statements by Steve, Avon and Somerset police have not made any arrests, or even organised identity parades. It was Steve's own solicitor who released artist's impressions of the two men to the press. In March the Guardian reported extensively on the whole case, and the issue was debated in the House of Commons.

Many sections of British society will find Steve's allegations easy to believe. During the Miner's Strike whole communities were placed under siege, and sickening accounts of violence and intimidation during those months are well-documented. Right now in Wapping the local residents and sacked workers are complaining of similar treatment in the Print dispute.

Police harrassment is a fact of life for the residents of Broadwater Farm in London. Only a week after the shooting of Cherry Groce, Cynthia Jarret died during a police raid and this led to a riot in which a policeman was killed. The police reprisals have been severe. Over 350 arrests have been made, often during dawn raids in which doors are smashed in and all the person's belongings confiscated. The arrest rate is still running at over 6 a week, even though half of those arrested have been released without charge.

Here in Manchester the experiences of Sam White and Jackie Berkeley reflect the kind of treatment that people in Moss Side have grown to expect from the police.

More and more groups are learning from experience, what police harrassment and intimidation really means. Now is the time for all of us to unite, and demand Justice; for Steven Shaw and all victims of police harrassment.
