## **ROSE & BRIAN MUST STAY**

Rose Alaso is a Ugandan student at Bradford University, who lives in Meanwood, Leeds with her seven year old son, Brian. She has lived in Britain since 1979.

Rose's family have been imprisoned, tortured, and even murdered by both the Amin and Obote regimes in Uganda. Rose's father, brother, sister-in-law and their children have been massacred.

Since 1982 Rose has been trying to obtain refugee status in this country. The Home Office have now finally rejected her application. This means that on 25th July Rose may be forced to return to Uganda.

The Home Office say that Rose is an illegal entrant because they claim that she did not live at the address specified on her admission papers. In fact Rose DID live at that address so she is by no means an illegal immigrant.

Only last month Amnesty International published a report about the abuse of human rights in Uganda. The report gives a horrifying account of torture and murder by the Ugandan army and secret police over the last four and a half years. Yet despite this the British Government, who support the Obote regime, seem determined that Rose should return to what would probably be her death. The British Government claim that the danger Rose and Brian face in Uganda is grossly exaggerated. However, Amnesty International disagree. They are fighting for Rose to gain political asylum.

Friends of Rose Alaso have been meeting to campaign with Rose in her fight to stay. We are a group of people from Leeds determined to prevent the government sending Rose and Brian back to Uganda.
