Both charges carry a maximum sentence of life imprisonment.

The 11 were remanded in custody to the Bradford police cells until and of August 5th, when they were futher remanded in custody until August 13th and 20th. Four defendants were remanded to Armley prison, Leeds, and the remaining seven to Thorpe Arch detention centre in Wetherby. The contract of the contract

The police claim that the charges are based on so called "voluntary statements", yet the fact remains that all 11 defendants are pleading not guilty. It has been proven in the past that the Bradford police obtained so-called "voluntary statements" by force.

Sir Thomas Hotherlanden In 1978 George Lindo, a Bradford West Indian worker, was convicted on the basis of a so-called "voluntary statement". This conviction was mobiled later quashed, when it was revealed that the statement was in fact written by a police officer and signed by George Lindo under duress.

In the same year a young Bradford whiteman, one Geoffrey Elliot, was alleged to have given a detailed "voluntary statement" to the Bradford police admitting to rape. This statement was subsequently discredited when another man admitted to the rape.

It is a fact that the 11 young Asians were subject to prolonged

interrogation and physical harassment. Concerned relatives and friends, as well as solicitors were not allowed to speak to or visit them, until some 48 hours after the initial arrests. Dan did wint very until . p. s. b. te syle bem. patimismos asten a ligarine all s

The July 11th Action Committee believes that the treatment of the young Asians and the charges brought against them amount to a political conspiracy against the Black community. It comes at a time of frequent and violent racist attacks on the members and property of the Black community in West Yorkshire and other parts of the country. The police have shown that they are not prepared to protect the Black community against the racists. In this situation the Black community has no choice but to defend itself. Young Blacks up and down the country have shown that they are prepared to do just that. The July 11th Action Committee also beleives that the charges brought against the 11 young Asians, are aimed at crushing the resistance of Black youth.
