## JASWINDER'S HISTORY

Jaswinder is an Asian Woman living in Leeds with her 3 year old son Manjit who was born here.

Jaswinder came to the country in 1975. In 1976 she married. Her husband was a violent and cruel man who often beat her and her child. In 1979 Jaswinder left her husband after a vicious assault on their son Manjit. Her husband was arrested and convicted of the assault. It turned out that he was already married and was a so-called overstayer, he was deported.

Now Jaswinder is threatened with deportation because it appears that because her husband was a so-called illegal immigrant she has no right to stay here because of the racist 1971 Immigration Act.

Why we must oppose the Deportation!

1. Black people have a right to come here and live here because of the hundreds of years of exploitation we suffered.
2. Jaswinder has committed no crime.
3. Jaswinder has lived here for 6 years!
4. Her son Manjit was born here!
5. Jaswinder works here!
6. If she is deported she will face further violence from her husband!
7. Manjit is a British Citizen and cannot be technically deported but effectively he is being deported!
8. Deportation will ruin the life of Jaswinder and Manjit.

THE RACIST IMMIGRATION LAWS ARE DESTROYING  
BLACK PEOPLE'S LIVES.

The deportation of Jaswinder and Manjit under the Racist 1971 Immigration Act is just further proof of the onslaught launched against Black people by the Racist British State.

The Black Community and other progressive people must move as one to prevent this monstrous outrage. Tomorrow the attack could be on you or I.

We must say enough is enough! We will tolerate no more! With the memory of those who fought and died trying to win out freedom from the British Raj we must stand up and say.

"We will Defend our Sister"

"We will Defend Jaswinder"

It is our duty. We must steel ourselves for the struggle and prevent this deportation by ANY MEANS NECESSARY.

ACT NOW! DON'T LET JASWINDER DOWN!

WHAT YOU MUST DO!

- (1) Write a letter to the Home Secretary protesting At the deportation.
- (2) Write to your Local M.P. or 'Bigwig' and get them to protest.
- (3) Get your organisation, Trade Union etc. to protest.
- (4) Organise a Public meeting about the case. Speakers can be arranged. Get local press publicity about the case.
- (5) Organise a social event to raise funds.
- (6) Organise Petitions.
- (7) Mobilise for the DEMONSTRATION on MAY 16th IN LEEDS. ASSEMBLE 2pm BANSTEAD TERRACE, ROUNDHAY ROAD, LEEDS 8
