NATIONAL DEMONSTRATION to DEFEND NASIRA BEGUM from DEPORTATION.

DEMONSTRATE IN SUPPORT OF ALL THREATENED BY THE IMMIGRATION LAWS

Nasira Begum is a Pakistani woman who lives in Stockport. Since last September she has been campaigning against a Home Office decision to deport her, Nasira is married to a British citizen, but her husband deserted her. Now the Home Office claims that her marriage was not valid, and classifies her as an 'illegal immigrant'. Their evidence against Nasira is so flimsy that it would be thrown out immediately in a court of law. But under the Immigration Laws immigrants have no access to a court of law. Nasira is now defending her case in an Immigration Appeals Tribunal. Her appeal began on May 8th, and has been adjourned until WEDNESDAY 23rd JULY.

RIGHTS DENIED

Legally, Nasira has every right to stay here, but the appeals procedure can't guarantee that right. The Immigration Laws, and the appeals procedure which goes with it, are designed to force black people out of this country. Under these laws black people are denied basic rights which are granted to white people. They are under constant threat of arrest without a warrant, indefinite inprisonment without trial or charge, and hundreds of people have their families broken apart.

Moreover, in an appeal the tribunal is not independent - the adjudicator is appointed by the Home Office, and all the rules are loaded against a chance of a fair hearing.

PUBLIC CAMPAIGN

In view of this we decided that a public campaign would be the only way to guarantee Nasira's right to stay in this country.

The campaign so far has succeeded in preventing her arrest, and stopping the Home Office from quietly deporting her. A big demonstration of support is very important for Nasira at this stage as she appraoches her final appeal on 23rd July.

DEMONSTRATION

This demonstration has been called to show our continued support for Nasira, and our opposition to the way in which she, and many other black people are being treated under the Immigration Laws. The demonstration is taking place on SATURDAY 19th JULY - just 4 days before Nasira's final appeal.

MOHAMMED BUTT: -Threatened with deportation because the Home Office say he has infectious T.B., a private consultant says he hasn't. On top of this he has been denied N.H.S. treatment.

ANWAR DITTA: -Since 1976 her three eldest children have been denied entry. The Home Office has consistently refused to accept evidence proving they are her children.

IBRAHIM ALI:

-dis eldest son has died during the 9 years the Home Office has made him wait to have his family with him. Two other sons are still waiting.

MUNIR AHMED: -Called for an interview with immigration officials at Manchester Airport - was immediately arrested and detained for deportation. His 'crime'? - failure to disclose information which he was never actually asked for!

SHUKAR MOHAMMED: -Lived and worked in Oldham for 20 years. After returning from a visit to Fakistan, he has only been granted a temporary visa as his zoor health is now seen as a burden on the Health Service.

NASREEN AKHTAR: -Lives in Rochdale with her children. The Home Office want to deport her because her husband has deserted her.

GIAS UDDIN: -Lived in Liverpool, deported by the Home Office because they questioned his identity, as he was known by a mickname which differed from his father's real name.

SALIM PARDESHI:- Lives in Longsight with his Family. The Home office want to deport him because his wife has left him.


