## NIGHAT NEEDS YOUR SUPPORT - LET TARIQ IN ON 26TH SEPTEMBER AT RINGWAY, MANCHESTER AIRPORT, FLIGHT KL153

### RACIST AND SEXIST MARRIAGE RULES

The racist and sexist marriage rules are used by the Home Office to control black immigration and to step up its attack on the basic human rights of black people to establish a family life in Britain. Nighat and Tariq's case is just one example of how black people are being denied the fundamental human right to have a family and to choose who they marry and where they settle with their partners.

# HOME OFFICE ATTACKS NIGHAT'S RIGHT TO CHOOSE

Nighat came to the UK in 1965 from Mirpur in Azaad Kashmir, Pakistan, at the age of 3 years. She became a British citizen in 1975. In 1979 she got engaged to Tariq Mahmood and then applied for Tariq to be allowed to join her in the UK. Nighat has not been allowed to have Tariq join her because the Home Office say that Tariq has NOT PROVED to them that his primary intent in marrying Nighat in NOT for settlement in the UK.

### HOME OFFICE ATTACKS ON TARIO

Tariq's whole family are settled in the UK. Tariq had initially applied to come to the UK in 1971 at the age of 13 years as the dependant of his father who was already in the UK. However the Home Office did not believe that Tariq was the G son of Abdul Rahim and therefore Tariq was not allowed to be with his family in the UK.

### TARIQ MAHMOOD IS TARIQ MAHMOOD !!!

Nighat went to Pakistan to support Tariq in his interview with immigration officers in March 1985. While Tariq's application was again turned down on 'primary intent', the Home Office now admit that TARIQ MAHMOOD IS TARIQ MAHMOOD!!!

Tariq has suffered enough by being kept apart from his family. Now Nighat and Tariq are both suffering by being denied the right to found a family in the dountry of their choice. NATURAL JUSTICE DEMANDS THAT THE HOME OFFICE ALLOW TARIQ IN.

Nighat is bringing Tariq back with her on 26th September. They will need all your support to get him through immigration. Tariq has applied for temporary admission for 3 months in order to sort out his legal situation. HE MUST BE ALLOWED IN.

COME TO THE AIRPORT TO WELCOME THEM AND MAKE SURE HE IS ALLOWED IN. TRANSPORT IS PROVIDED BETWEEN 7.15AM and 8.15AM AT TEMPLE SCHOOL; CHEETHAM HILL ROAD, CHEETHAM HILL and ATLONGSIGHT LIBRARY, STOCKPORT ROAD, LONGSIGHT.
